### A MATTER OF CHOICE: CONSTITUTIONAL RATIFICATION IN THE STATES

Stephen Schechter, Department of Government, Russell Sage College, has received a planning grant from the National Endowment for the Humanities for the 200th anniversary of the U.S. Constitution. The funded project will explore the feasibility of public education activities having to do with the ratification of the proposed U.S. Constitution by the original thirteen states. Planned activities include: (1) a three-semester series of public lectures and other learning activities on the ratification process in New York state; (2) a single catalyzing event in the other original-states on their ratification dates; (3) a television documentary on the ratification process in the states; and (4) preparation of a collection of essays on the states and the ratification process. The term of the planning grant is January 1, 1983 to December 31, 1983.
