### CENTER HOSTS A DIALOGUE ON THE PRACTICE OF AMERICAN FEDERALISM

On February 23, 1978, the Center for the Study of Federalism hosted the third Dialogue in the series commemorating the tenth anniversary of the Center's founding. The topic of discussion was The Practice of American Federalism.

The Dialogue was divided into two sessions; the first dealt with administration, the second concentrated on politics. The principle speaker at the first session was David Walker, Assistant Director of the Advisory Commission on Intergovernmental Relations. The principle speaker at the second session was Deil Wright, Professor of Political Science at the University of North Carolina. Discussants at both sessions included Robert Horton, Office of the Mayor, Nashville, Tennessee; Diane Kincaid, Department of Political Science, the University of Arkansas; Samuel Halperin, the Institute for Educational Leadership, Washington, D.C.; Robert B. Hawkins, Jr., the Woodrow Wilson International Center for Scholars, Washington, D.C.; and



E. Lester Levine, Department of Finance, the State of Minnesota, St. Paul, Minnesota. Other participants came from a wide range of academic and governmental institutions.

We are currently planning the fourth Dialogue in this series. It will deal with medium-sized cities and it is tentatively scheduled for mid-May of this year. As was the case in the preceding Dialogues, the Center will offer limited travel grants to Conference members who would like to attend this Dialogue. Those Conference members who want to be considered for such a grant should send a letter explaining their interest in the topic and containing a budget of estimated expenses. THE ASSOCIATION OF CENTERS FOR FEDERAL STUDIES  
SCHEDULES A JUNE 1978 MEETING

The Association of Centers for Federal Studies (ACFS) will hold its first conference and second annual business meeting from June 27 to June 30, 1978, in Aosta, Italy. The conference will be hosted by the unit of the Centre International de Formation Europeene (CIFE) located in Aosta. The principle theme will be Federalism and Regionalism.

The conference's initial agenda includes the presentation of case studies (on Spain, Quebec, the United Kingdom, the Vallee d'Aosta, and Wallonie) and topical presentations (on federalism and regionalism, the federalist significance of the election of the European Parliament, and territorial and integral federalism). A final conference program will be prepared by the host center. All inquiries should be addressed to Ferdinand Kinsky, Directeur General, c/o C.I.F.E., 4 Boulevard Carabacel, 06200 Nice, France.

The 1978 business and research meetings of ACFS will be held immediately prior to the conference. Current indications are that representatives from all ten centers in the Association will be in attendance. Most of the Associations' Working Groups (see volume 7, number 3 of *CFS Notebook*) will also use the opportunity to meet and offer presentations of work in progress. A full report on the conference and the business meetings should be available shortly afterward from the Center for the Study of Federalism, which serves as the secretariat of the association.

1978 TAFT SEMINAR FOR TEACHERS TO BE  
SPONSORED BY THE CENTER FOR THE STUDY OF FEDERALISM

The Center for the Study of Federalism has been selected as one of the sponsors of the 1978 Taft Seminars for Teachers. The principal program of the Robert A. Taft Institute of Government, these seminars offer an opportunity for elementary and secondary school teachers to increase their understanding of American government, politics, and the two-party system, and to improve their teaching methods. Seminar participants pay only a small registration fee and they receive funds provided by the Taft Institute for tuition, meals and books. Temple University offers three hours of graduate credit for each participant.

Thirty-five teachers, principals and school administrators from Pennsylvania and surrounding states will be chosen to meet on Temple's Center City campus during the weeks of August 7 through August 24 with a unique faculty of experienced politicians from both the Republican and Democratic parties. Among the speakers "teaching the teachers" will be elected officials from local, state, and national units, as well as party leaders, lobbyists, political reporters, business executives and labor representatives. Daniel J. Elazar and other members of the Center's staff will be responsible for the academic content of the seminar.

During 1977, over 1,000 political experts met with teachers at 35 Taft seminars across the country. Colleges and universities hosting the 36 Taft Seminars in 1978 are located in 30 different states. The Robert A. Taft Institute is a nonpartisan, nonprofit, and educational institution. Financial support for the Seminars is raised by the Institute each year from individuals, corporations, and foundations.

CONFERENCE ON FEDERALIST SOLUTIONS FOR THE  
ISRAEL-ARAB CONFLICT HELD AT BAR-ILAN UNIVERSITY

From January 30 to February 2, 1978, the Senator N.M. Paterson Chair in Intergovernmental Relations of the Department of Political Studies at Bar-Ilan University and the Jerusalem Institute for Federal Studies hosted the Second Annual Paterson Conference on Federal Responses to Current Political Problems. The topic of this year's conference was "Federalist Solutions for the Israel-Arab Conflict." The Sessions were held on the campus of Bar-Ilan University in Ramat-Gan, Israel.

The conference brought together political scientists, economists, sociologists, anthropologists, and political decision-makers from within Israel and many other countries around the world.
